Victim Impact Panels (VIPs)



The purpose of the Victim Impact Panel (VIP) program is to help drunk and drugged driving offenders to recognize and internalize the lasting and long-term effects of substance-impaired driving; create empathy and understanding, leave a permanent impression; and prevents future offenses.

At a VIP, victims, survivors and others impacted by substance-impaired driving crashes speak about the crash in which they were injured and/or a loved one was killed or injured.



On August 27th, Law enforcement agencies from around the state came together on one weekend in a show of force to catch intoxicated drivers through saturation patrols and checkpoints. This was New Mexico's 4th year participating in this nationwide initiative.
